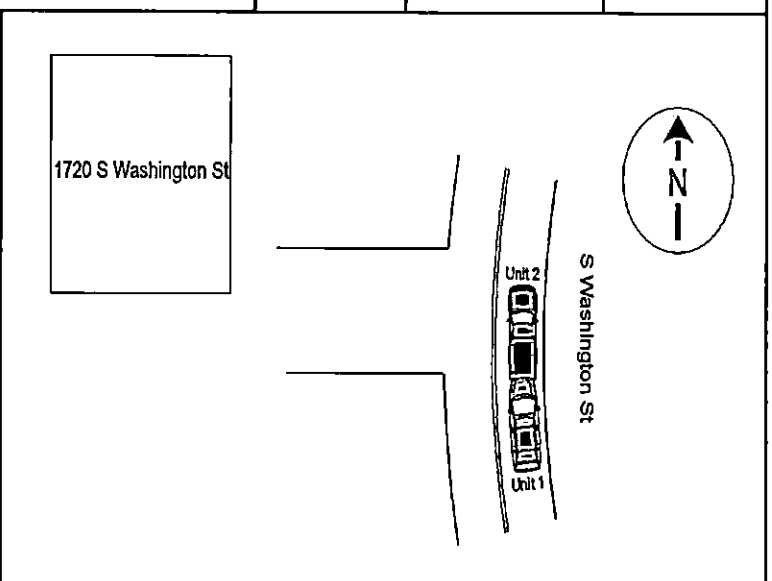

NARRATIVE

Unit 02 was stopped on S Washington St waiting for traffic to clear to make a left turn into Tractor Supply. Unit 01 was northbound on S Washington St. Unit 01 rear-ended Unit 02. Unit 01 said he wasn't sure what happend. Unit 01 asked if Unit 02 brake lights were working. Unit 02 stated everything was working appropriately prior to the crash. I was stationary in Tractor Supply parking lot facing S Washington St. I observed Unit 02 stopped to turn into the business. I watched Unit 01 not slowing down and strike Unit 02, causing Unit 02 rear end to come up off the ground onto Unit 01 and then slide off to rest just in front of Unit 01.



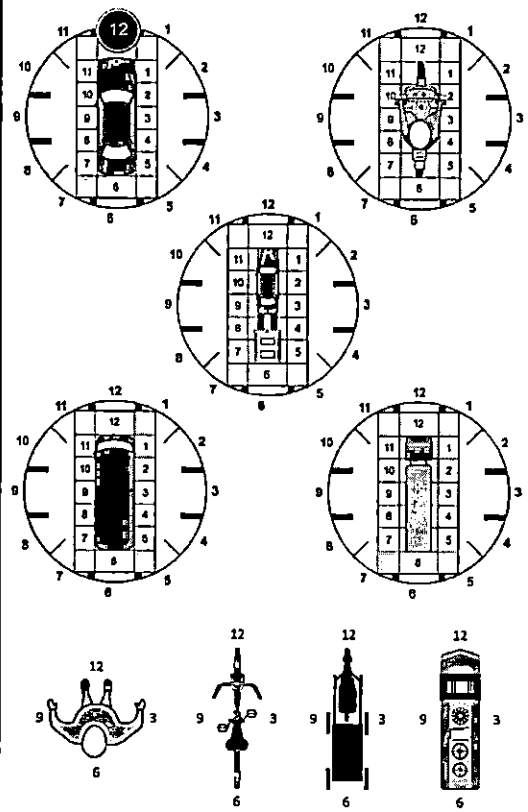

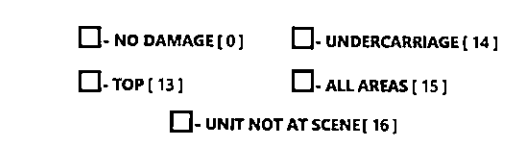
