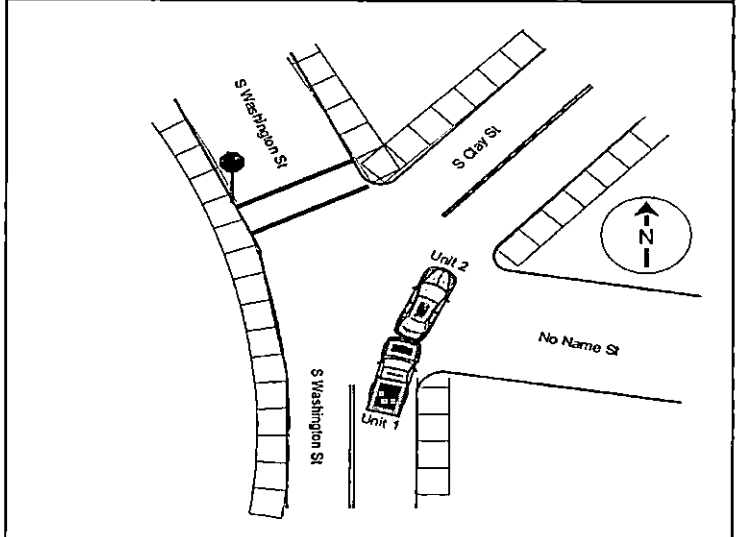

Unit 02 was northbound on S Washington St, stopped in traffic to turn up S Washington St. Unit 01 was northbound on S Washington St. Unit 01 stated he was unsure what happened and saw Unit 02 stopped to turn. Unit 01 applied the brakes but was too late in doing so and rear ended Unit 02, pushing Unit 02 up the hill. This caused disabling damage to both Units and Unit 01 to obtain a bloody mouth from hitting the steering wheel.
