- 5. REPLACEMENT IS NOT NECESSARY IF OTHER MEANS ARE AVAILABLE (GRINDING, LEVELING, ETC.) HOWEVER, THE PROPERTY OWNER IS RESPONSIBLE FOR ENSURING THESE MEASURES ARE ADEQUATE.
